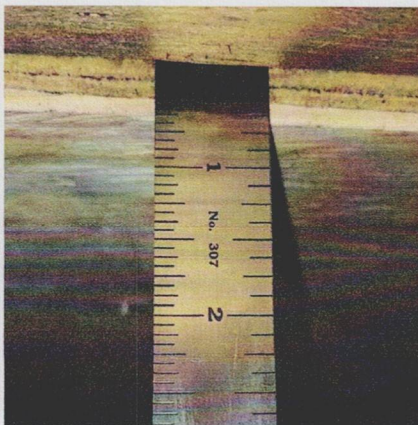

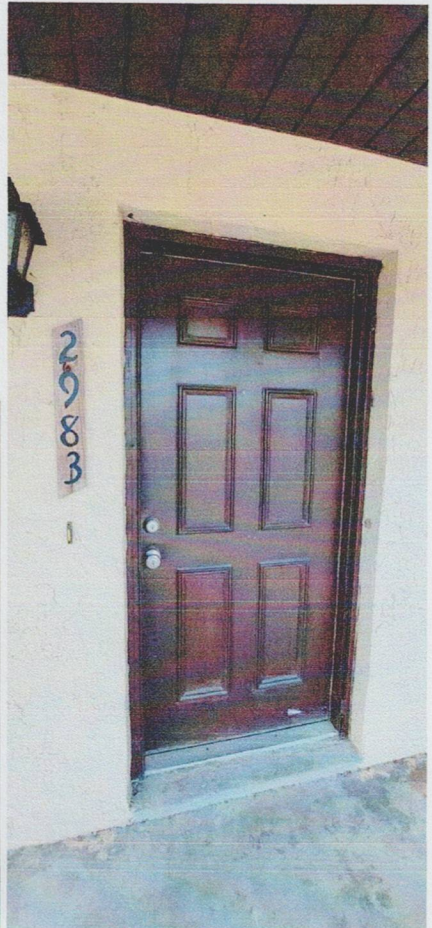

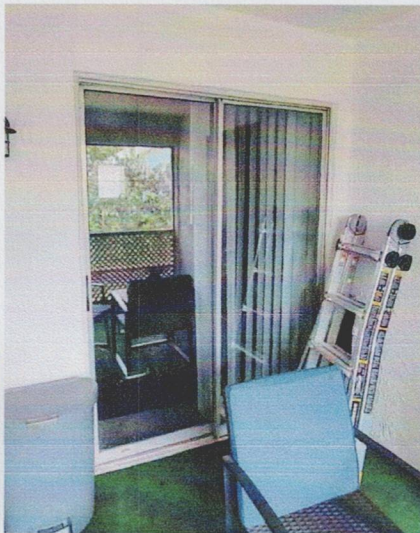

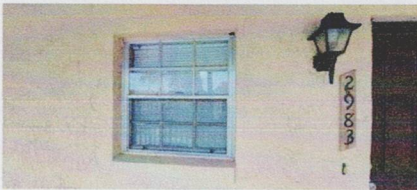
Single Wraps
